The Department of the Environment has granted planning permission for the following planning application:-

Fermanagh District Council Area

Location: Townlands of Glenarn, Stranahane, Stranadariff and Carrick at Tappaghan Mountain, Lack, Cos Fermanagh and Tyrone

Proposal: Amendment to proposal to extend Tappaghan windfarm including a reduction from 8 to 6 turbines (each with a maximum overall height of 99.95m), associated transformers, a permanent anemometer mast, an extension to the existing substation, new access tracks and gates, electrical cabling, a temporary site compound and all ancillary works including extraction from the borrow pit on site to provide construction materials.
